## DETAILED NOTICE INVITING TENDER

### 1.0 Introduction:

Government of Odisha proposes to cover command area of about 2.0 lakh Ha through mega lift irrigation schemes under Engineering Procurement and Construction contracts on Turn Key Basis by utilizing available surplus water in different river basins. The individual lift schemes are being planned to cover 500 Ha to 2000 Ha for providing irrigation facilities to rain-fed uplands close to the river on either side and also close to existing reservoirs. The Mega Lift schemes are primarily aimed for supplementation for Kharif water demand in the upland command areas of respective schemes. Normally the Irrigation supply for Kharif starts after 20<sup>th</sup> June and ends by 15<sup>th</sup> November depending upon water availability & rainfall. Rabi Irrigation shall be provided only on availability of water and Rabi crop planning duly approved by District Authority.

**1.1** Through this tender, it is now proposed to take up the schemes of cluster-Malkangiri . There are 8 nos. of Lift Irrigation Schemes in this cluster with CCA of 11,830 Ha. which are located on Chitapari nadi Potteru, Saberi, Garia, Kolab river. The Broad conceptual layout (BCL) of all the schemes have been prepared based on Topo sheet Planning. Salient features of the schemes based on the planning, is furnished herewith in the Basic Project Profile in the Bidding Document. The locations of schemes are shown in the index map. The salient features and the drawings provided are for guidance only. Since the present tender is an EPC tender, the contractor is to plan and design the schemes after detailed survey and investigation. Depending on site conditions and suitable O&M conditions, schemes may be combined up to CCA of 2000 Ha under approval of the Department.

**1.2** Major components of each scheme are Intake pipe, Intake structure, Pump house, Rising Main/Pressure Main from pump house to Delivery Chamber(Optional), Distribution System (Distributary Main, Minors, and Outlets etc.) Pumping Machinery, Electrical work inside Pump House & system Networking/Switch yard including connectivity from selected 132/33 KV Grid Sub-station and/or Distribution Licensee's 33KV network.

### 2.0 INVITATION:
