

Pre-bid conference for Expression of Interest for recruitment of Firm/Consultant for Survey, Design and related services for Main Canal & Distributaries of Pattamundai, Machhagaon, High Level Canal R-1 and Kansbahal Sub-projects.

A pre-bid conference for the work "Survey and Design on Main & Distributary canals of Pattamundai, Machhagaon, High Level Canal Range-1 and Kansbahal subprojects" was held under the Chairmanship of the Chief Engineer-cum-Project Director, PMU (OI/AWMIP) on 15.12.2011 at 11.00 A.M. in the conference hall of Project Management Unit, 5th Floor, Rajiv Bhawan, Bhubaneswar. List of participants is enclosed herewith.

At the outset, the CE-cum-PD, PMU welcomed all the Consultants/their authorised representatives and briefed them about the assignments and objectives of the Expression of Interest for survey, detailed design and related services for 4 sub-projects i.e., Pattamundai, Machhagaon, HLC R-1 and Kansbahal. The details of assignments to be carried out by the successful bidder and their deliverables, etc. as per ToR were clearly explained to the participants. He invited the perspective bidders to raise any doubt, ambiguity and queries, if any, regarding the bid documents.

All the bidders appreciated the preparation of the bid documents since they are self-explanatory and complete in all respect. However, some of the bidders wanted clarifications as tabulated below:

The Consultant shall link the transferred datum to DoWR benchmarks along the canal and any discrepancies notice shall be brought to the notice of the EE. The EE will then define the datum to be used for the project.</p> <p>The key consulting staff for professional, technical and admn. reflected in the bid document are minimum & indicative only. The Consultant may wish to adjust staffing input to suit his work programme and methodology. This has been clearly spelt out in the bid document.</p> <p>There is no specific requirement for satellite imagery, but if the Consultant feels it would be beneficial, he may procure. The deptt. will assist with supporting letter but the cost would be the Consultant's responsibility. Please refer Detailed Terms of Reference-clause 'B'.</p> <p>Detailed CVs are not required for the team members at this stage. The firm should provide the information in tabular form detailed in Section III, C for permanent staff of the firm according to the three sectors given. CVs for team members will be required at the proposal stage during the technical & financial proposal submission time.</p> |

The Consultant shall also consider Structural Engineer in case of Machhagaon sub-project.</p> <p>If any Firm is interested to bid for multiple packages they may have the choice to utilise the services of Procurement Specialist and Geo-Tech. Engineers so long as they can work comfortably in their required field without any over-utilisation. But their sharing in multiple projects (not more than 2) shall be considered depending on the geographical position of the subprojects for utilisation of services simultaneously in both the projects.</p> <p>No space can be provided to the Consultant by the deptt. It is the responsibility of the Consultant to make their accommodation. (see section-IV).</p> <p>iii) Section-III, page-2: As per `C'- Consultant's Professional Personnel, date of birth, nationality, period with the firm, qualifications, years of experience of consultants are to be provided. It is presumed that qualifications include educational qualification as well as outline of staff members' experience. It is suggested that a format for CV may be provided to have uniformity in submission of Eol's by different consultants.</p> <p>iv) It may please be mentioned whether there is any age limit for professional staff or any relation between age and evaluation criteria.</p> <p>v) Section-III, page-3: under "3.Existing Commitments and on-going works" please clarify the description of works only of similar nature are to be given or all the on-going works of the company are to be given.</p> <p>vi) In case of an association or sub-consultancy, whether same weightage will be given in evaluation for both the lead firm and the associate(s) or the main consultant and the sub-consultant(s).</p> <p>vii) Section-III, page-3: What does ETB mean ?</p> | <p>The last date of submission of Eol is now extended to 1.00 P.M. of 11.01.2012 instead of 03.01.2012 for all the packages. The same shall be opened at 3.30 P.M. on the same day. Necessary corrigendum is being issued separately which can be seen in the same website where original notice was floated.</p> <p>The intention in the Eol is to assess the Consultant's permanent professional personnel in the three sectors indicated. It was also further clarified by PD, PMU as under:

1. In case of joint venture, copy of the agreement in Govt. stamp paper need have to be produced along with the EoI.
2. In case of joint venture, the lead partner must have minimum 40% of the annual average turnover and other partner shall have minimum 25% of the required annual average turnover. The lead partner shall be accountable for all purpose.
