**NOTIFICATION**

Sub: Procedure for permission/ allocation (NOC) of water for drinking & domestic use in the state of Odisha.

As per the provisions of Orissa Irrigation Act, 1959 & Orissa Irrigation Rules, 1961 (amended from time to time), water allocation from Government water source & Irrigation works is being made for drinking & domestic use in the state of Odisha. State Water Policy has prioritized Drinking & domestic use of water as first priority among other uses. Keeping in view the above mandate, the Government in the Department of Water Resources have been pleased to decide the following procedure for smooth & timely allocation of water for drinking & domestic use:-

All requests for issue of NOC for water supply projects by Panchayati Raj & Drinking Water Department & Housing & Urban Development Department must be processed without any delay at any level & it must be issued forthwith by Government. EE of the requisitioning Department shall apply to the Principal Secretary to Govt., DoWR as per the provision of the Rules, with a copy to the concerned EE of DoWR, under whose jurisdiction the project is coming. After receipt of the request, the concerned EE of DoWR along with the EE of the requisitioning dept. shall conduct a joint enquiry to identify the source, existing or proposed interventions required for ensuring water supply throughout the year. While locating sources; existing barrages, dams, reservoirs or any such existing structures must be considered, so that no additional intervention is required for smooth water supply, preferably from the up-stream of existing structures. Where no structural intervention is required, both the EEs shall send the report to EIC, WR for vetting in the WAC meeting. Recommendation to Govt. in DoWR may be

sent by WAC forthwith after receipt of the joint verification report from both the EEs. Where structural intervention is required, EE of DoWR concerned shall immediately send the proposed structure for approval of Technical Advisory Committee (TAC). After approval in TAC, the concerned EE shall send the hydraulic particulars for design of the structures with intimation to the requisitioning Department. After necessary design steps shall be taken by DoWR for taking up immediate execution of work. Concerned Department shall place funds for execution of such structure.


Any clarification regarding implementation of this Notification for allocation of water shall be issued by the Government in Department of Water Resources.

This Notification shall come into force from its date of issue.






