Consequent upon incorporation of the Odisha Hydro Power Corporation Ltd. (OHPC) on 01.04.1996, all the completed multi-purpose hydro projects like Rengali, Balimela, Hirakud & Upper Kolab and the then ongoing Project like Upper Indravati were transferred to its control from the said date on as is where is basis.


However, Water Resources Department are maintaining all the Dam Projects except Upper Indravati Hydro Electric Project (UIHEP). The OHPC is maintaining the Dam of UIHEP. The maintenance cost of these Dams are being shared between the Corporation and DoWR in accordance with ratio indicated in Water Resources Department letter No.FE-III-IE-C-58/99/24415 dt.07.07.1999 which was addressed to Energy Department. But no specific Resolution / Notification has been issued by any of the Administrative Departments. This issue was discussed in the meeting taken by Additional Chief Secretary, Finance held on 23.03.2015 for settlement of issues of OHPC. It is felt imperative to spell out the sharing pattern in the shape of a Resolution. The Dam maintenance costs are shared taking into consideration the ratio of Capital Cost of Irrigation, Power Generation & Flood Control component of the Projects.

Keeping in view the above position, Government, after careful consideration, have been pleased to approve the sharing pattern of dam maintenance cost of different intra-State Hydro Power Projects between Water Resources Department & OHPC in the ratio indicated against each as mentioned below:-
